// **IMPORTANT NOTES** NON-REFUNDABLE REGISTRATION FEE OF \$40 (PER FAMILY) IS DUE ON OR BEFORE 6/14/24, FOR REGISTRATION TO BE CONSIDERED COMPLETE; SEPTEMBER TUITION PAYMENT MUST BE SUBMITTED BY 9/1/24 IN ORDER FOR YOUR CHILD(REN) TO BEGIN ATTENDING THE 2024-2025 SCHOOL YEAR PROGRAM AT SACC.



**PAYMENT STRUCTURE** Tuition is based on a total of 180, 3 hour sessions, in a school year. Monthly payments are divided equally over 10 month period. Tuition is due as outlined above and late fees will be assessed as noted below. *September and June must be paid by the 1st of the month - no extensions.*

**LATE / RETURNED PAYMENT** Late fee of \$25 will be imposed if payment is received after the 5th day of the month and an additional late fee of \$5 per day will be incurred until tuition is paid for that month. *Returned check or declined credit card transaction will result in a penalty of \$50. After one instance of a returned check, remaining payments will only be accepted in the form of cash or money order.*
